**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HESPERIA,
CALIFORNIA ESTABLISHING HESPERIA'S COMMITMENT TO
PROMOTING AND DEVELOPING A SAFE AND HEALTHY HESPERIA**

WHEREAS, the City of Hesperia has placed a high priority on improving the quality of life for its citizens; and

WHEREAS, the City of Hesperia is committed to developing programs, policies and opportunities that support healthy, active lifestyles; and

WHEREAS, the City of Hesperia believes that there are important, long-term community benefits to be gained by encouraging healthy lifestyles, including a potential decrease in the rate of childhood obesity and its negative health-related impacts; and

WHEREAS, local government agencies are uniquely positioned to influence, implement and integrate development, revitalization, and open space strategies that take health benefits into account; and

WHEREAS, the City of Hesperia has an opportunity to improve the public health of its citizenry through the creation of a Healthy Hesperia Committee; and




Section 3. That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.


